**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT  
OF TARIFF OF THREE GORGES SECOND WIND FARM PAKISTAN LIMITED**






4. CPPA-G to ensure that all the payments are consistent with tariff determination.



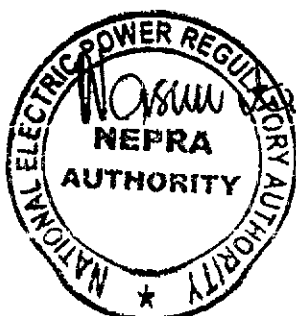
