**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE
ADJUSTMENTS FOR THE MONTHS OF JUNE TO DECEMBER 2024 FOR
ENGRO POWERGEN THAR (PVT.) LIMITED**

1. Pursuant to the decision of the Authority dated March 13, 2015, in the matter of approval of Thar Coal Upfront Tariff for 2 x 330 MW Coal Power Plant of Engro Powergen Thar (Private) Limited (hereinafter refer as "EPTPL"), the variable and fixed fuel cost components are subject to adjustment on the basis of coal price determined by Thar Coal Energy Board (TCEB) and notified in the Official Gazette.
2. NEPRA vide its letter dated May 22, 2024 directed EPTPL to file request for adjustments of Fuel Cost Components (FCCs) of the relevant period within one month on the basis of TCEB's decision dated March 13, 2023 in the matter of quarterly indexations/adjustments of Phase-I of Block-II of mine tariff for July-September 2019 to July-September 2022. Failure to do so, the future FCCs shall be put on hold. EPTPL could not file the requisite adjustment request, accordingly, the revised FCC decision was put on hold w.e.f. June 2024.
3. Subsequently, TCEB vide its decision dated August 12, 2024 also published quarterly indexed/adjusted tariff for the period October 2022 to March 2024. EPTPL vide its letter dated December 11, 2024 submitted requisite adjustment request for the period July 2019 to March 2024 for Phase-I and Phase-II on the basis of revised invoice issued by Sindh Engro Coal Mining Company (SECMC).
4. Based on the EPTPL's submissions and requests and above discussions, the Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-

"Based on the documentary evidence and information submitted by EPTPL, the variable and fixed fuel cost components of the energy charge part of EPTPL's tariff for the months of June to December 2024 are adjusted for variation in Thar coal price(s). The revisions in fuel cost components are provisional and subject to further adjustment, in the light of applicable indexations decision(s) by TCEB for Phase-II of Block-II."

5. The revised energy charge part of EPTPL's tariff relating to fuel indicated hereunder shall be immediately applicable to the units delivered during the months:

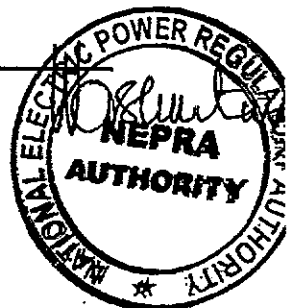

6. The decision pertaining to adjusted FCCs for July 2019 to ~~September~~ ^{March} 2024 shall be issued separately.
7. The Authority vide its decision dated June 15, 2022 approved the tariff at COD stage. EPTPL filed a petition before the Honorable High Court of Sindh (hereinafter refer as "SHC") against the decision of the Authority dated June 15, 2022. The SHC through its Order dated July 20, 2022 suspended the decision dated June 15, 2022. EPTPL also challenged the COD decision in the NEPRA Appellate Tribunal (NAT) and NAT on October 6, 2022 passed Order that recovery of costs imposed by impugned order (COD order) is suspended and indexation be allowed to the appellant according to indexation adjustment already allowed by NEPRA on provisional basis, subject to the final outcome of this appeal. Accordingly, the revised fuel cost components have been worked out in pursuance of decision dated March 13, 2015.
8. This decision along with **Annex-I to VII** are to be notified in the official Gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
9. CPPA(G) to ensure that all payments are consistent with tariff determination(s).

As per phase-II decision dated Dec 29, 2022, TCEB did not allow the transportation charges of mine-mouth coal power plants, therefore, US\$ 1.45/ton has not been included in the price(s) of coal purchases from March 2023 to May 2024.

TCEB vide letter dated April 28, 2023 issued clarification to SECMC to invoice transportation cost in-line with what was authorized in Phase-I COD Stage Tariff during the interim period till the time Phase-II COD stage tariff is determined. However, it is noted that TCEB did not allow transportation charges in COD stage Tariff, therefore, the same has not been included in the price(s) of coal for May 2024.
