**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR BEST GREEN ENERGY PAKISTAN LIMITED**

Pursuant to the decision of the Authority dated November 16, 2017 in the matter of tariff adjustment of Best Green Energy Pakistan Limited (BGEPL) at Commercial Operations Date (COD) notified vide SRO 23(I)/2018 dated January 05, 2018, BGEL has requested for the adjustment in the insurance component of tariff of the period from July 31, 2022 to July 30, 2023.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:


"Based on the information provided by the BGEPL, adjustment in insurance component for the period July 31, 2022 to July 30, 2023 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."




*Revised insurance premium works out to be 0.10% of the approved EPC cost.



4. CPPA-G to ensure that all the payments are consistent with tariff determination.


