## DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF FOR AJ POWER (PVT.) LIMITED

Pursuant to the decision of the Authority dated July 08, 2019 in the matter of tariff adjustment of AJ Power (Private) Limited at Commercial Operation Date (COD) notified vide S.R.O. 1157(I)/2019 on September 19, 2019. Thereafter, the Authority approved the Application/Review Motion for Revision of Upfront Tariff Determination of AJPPL filed by CPPA-G for Reduction of ROE and Q&M Component and Decision of the Authority was issued on April 9, 2021. AJPPL has requested the insurance cost and corresponding component of based on insurance cost for the period from Dec 14, 2023 to Dec 13, 2024.
