**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE  
COMPONENT OF TARIFF FOR JHIMPIR POWER (PVT.) LIMITED**

Pursuant to the indexations/adjustment mechanism stipulated in the decision of the Authority dated November 19, 2018 in the matter of tariff adjustment of Jhimpir Power (Pvt.) Limited (JPPL) at Commercial Operation Date (COD) notified in official gazette on March 21, 2019 vide S.R.O. No 399(I)/2019, JPPL has requested the insurance cost and corresponding component of based on insurance cost for the period from March 16, 2024 to March 15, 2025.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the JPPL, adjustment in insurance component for the period March 16, 2024 to March 15, 2025 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."
