**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR HAWA ENERGY (PVT.) LIMITED**

Pursuant to the indexations/adjustment mechanism stipulated in the decision of the Authority dated November 19, 2018 in the matter of tariff adjustment of Hawa Energy (Pvt.) Limited (HEPL) at Commercial Operation Date (COD) notified in official gazette on February 13, 2019 vide S.R.O. No 369(I)/2019, HEPL submitted request for adjustment of insurance component tariff for the period from March 15, 2024 to March 14, 2025. HEPL has claimed the total insurance of Rs. 138,496,433 (excluding sales tax).

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the HEPL, adjustment in insurance component for the period March 15, 2024 to March 14, 2025 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."

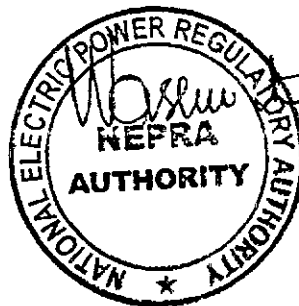
4. CPPA-G to ensure that all the payments are consistent with tariff determination.
