**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR TRICON BOSTON CONSULTING CORPORATION PVT LTD-A.**

Pursuant to the indexations/adjustment mechanism stipulated in the decision of the Authority dated April 01, 2019 in the matter of tariff adjustment of Tricon Boston Consulting Corporation Private Limited-A (TBCCPL-A) at Commercial Operation Date (COD) notified vide S.R.O. No 862 (I) 2019 on July 05, 2019, TBCCPL-A submitted the request for the revised insurance component of tariff for the period from November 22, 2024 to November 21, 2025 is tabulated as hereunder,

Revised Insurance premium works out to be 0.61 % of the approved EPC cost.


