**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR FFC ENERGY LIMITED (FFCEL)**

Pursuant to the decision of the Authority dated November 10, 2014 in the matter of tariff adjustment of FFC Energy Limited (FFCEL) at commercial operation date (COD) and decision of the Authority dated May 27, 2022 in the matter of motion for leave for review filed by FFCEL against COD tariff adjustment decision, FFCEL submitted request for adjustment of insurance component tariff for the period from July 01, 2024 to June 30, 2025.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the FFCEL, adjustment in insurance component for the period July 01, 2024 to June 30, 2025 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."

* Revised Insurance premium works out to be 0.33 % of the approved EPC cost.



4. CPPA-G to ensure that all the payments are consistent with tariff determination.

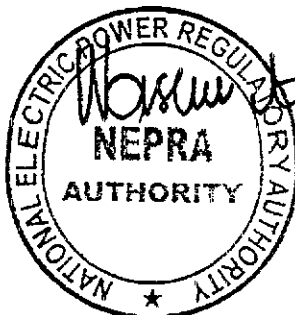
