# DECISION OF THE AUTHORITY IN THE MATTER OF REVISED COST OF WORKING CAPITAL COMPONENTS (RLNG & HSD) OF TARIFF FOR QUAID-E-AZAM THERMAL POWER (PRIVATE) LIMITED FOR JANUARY-MARCH 2025 OUARTER.

- Pursuant to the Authority's decision dated January 3, 2023, notified vide SRO No. 182(I)/2023 dated February 14, 2023, in the matter of Commercial Operations Date (COD) adjustment of 1181.51 MW (Gross) Quaid-e-Azam Thermal Power (Private) Limited (hereinafter "QATPL") project on RLNG/HSD at Bhikki, Sheikhupura, Punjab, the cost of working capital component of tariff is required to be adjusted on account of Fuel Price(s) and KIBOR variation.
- 2. The Authority vide its decision dated January 20, 2025 approved cost of working capital components (RLNG & HSD) for January-March 2025 quarter. Subsequently, QATPL has submitted a request for revised cost of working capital components (RLNG & HSD) on the basis of Rs. 3,739.21/MMBTU and submitted that cost of working capital components of Rs. 0.2238/kW/h and Rs. 0.2439/kW/h for RLNG & HSD respectively were determined on the basis of Rs. 3,124.46/MMBTU instead of Rs. 3,739.21/MMBTU. The request of QATPL has been considered by the Authority and accordingly cost of working capital components (RLNG & HSD) have been revised for January-March 2025 quarter in accordance with the requisite indexation/adjustment mechanism stipulated in the above decision(s) of the Authority.
- 3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of Authority in the matter:-

"Indexation/adjustment for January-March 2025 quarter has been made in the cost of working capital components (RLNG & HSD) of tariff in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised components are indicated hereunder shall be immediately applicable."

- 6. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).
