DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR ENGRO POWERGEN QADIRPUR LIMITED

- Pursuant to the Decision of the Authority dated April 01, 2011 in the matter of Motion for Leave
 for Review against the Decision of the Authority at COD, Corrigendum of the Authority dated
 May 14, 2012 and Decision of the Authority dated June 9, 2016 in the case of Engro Powergen
 Qadirpur Limited (hereinafter "EPQL"), the fuel portion of energy charge part of tariff of EPQL
 is required to be adjusted for variation in gas price(s).
- 2. The Honorable Supreme Court of Pakistan in its Judgment dated August 13, 2020 has restrained the Federal Government from charging Gas Infrastructure Development Cess (GIDC) until the amount collected and accrued has not been expended on the projects as listed in the Section 4 of the GIDC Act, 2015.
- 3. Ministry of Energy (Petroleum Division) vide its letter No. DGO (AC)-8 (49)/20 dated August 19, 2020 directed the concerned entities that the gas bills for the month of August 2020 and onwards will not include or reflect GIDC rates and will remain unbilled till further orders.
- 4. Oil and Gas Regulatory Authority (OGRA) vide its notification dated June 29, 2025 has notified gas price of Rs. 1,225/MMBTU with effect from July 1, 2025. Based on OGRA's notified gas price and in accordance with the adjustment mechanism stipulated in the decisions of the Authority, the fuel cost component has been revised. The revised energy charge part of EPQL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:
