- 2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF REVISION IN THE PREVIOUS APPROVED FUEL COST COMPONENTS FOR THE MONTHS OF OCTOBER 2024 TO DECEMBER 2024 FOR ENGRO POWERGEN THAR (PVT.) LIMITED

- 1. Pursuant to the decision of the Authority dated March 13, 2015, in the matter of approval of Thar Coal Upfront Tariff for 2 x 330 MW Coal Power Plant of Engro Powergen Thar (Private) Limited (hereinafter refer as "EPTPL"), the variable and fixed fuel cost components are subject to adjustment on the basis of coal price determined by Thar Coal Energy Board (TCEB) and notified in the Official Gazette.
- 2. The Authority vide its various decisions has determined fixed and variable fuel cost components for the months of October 2024 to December 2024 on the basis of reference Mine COD of Phase-II Tariff determined by TCEB and invoiced by its fuel supplier i.e. Sindh Engro Coal Mining Company (SECMC) to EPTPL. These FCCs are required to be revised on the basis of quarterly indexed/adjusted mine tariffs determined by TCEB for October-December 2024 quarter. TCEB issued its decision on quarterly indexed/adjusted mine tariff through Order dated February 25, 2025 and notified in the Government of Sindh's Official Gazette on March 17, 2025.
- 3. EPTPL vide its letter dated June 26, 2025 submitted request for the revise of FCCs for October to December 2024, based on TCEB's quarterly indexation decision for October-December 2024 quarter of Phase-II of Thar Coalfield Block-II. This request was made after EPTPL received the requisite invoice from its coal supplier on May 17, 2025. Additionally, EPTPL sought approval of Rs. 440,002,000/- as pass-through for duties and taxes incurred and invoiced by SECMC, based on TCEB's note, "Duties and taxes to be recovered based on actuals for respective quarter" in the quarterly indexation decision.
- 4. The Authority has considered the submissions of EPTPL. It has been noted that the request for pass-through of duties and taxes is without any verification and approval of TCEB and cannot be considered. Therefore, EPTPL is directed to ask its fuel supplier to get it verified and approved from TCEB and submit revised request along with TCEB decision in the matter and documentary evidence for consideration of the Authority. Based on the above decision of the Authority, the requested duties and taxes amount of Rs. 440,002,000/- has been set aside.
- 5. Based on the EPTPL's submissions, documentary evidences and above discussions, the Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-

"The previously approved variable and fixed fuel cost components of the energy charge part of EPTPL's tariff for the months of October 2024 to December 2024 are being revised on the basis of TCEB's quarterly indexation/adjustment decision for October-December 2024 quarter, as the first in Official Gazette, excluding taxes and duties of Rs. 440,002,000/-. EPTPL is directed to ask its all supplier i.e. SECMC to get the exact amount of taxes and duties verified and approved.





from TCEB. On the basis of approval and verification by TCEB, SECMC shall invoice the same to EPTPL who will submit the same along with documentary evidence for consideration of the Authority."

- 6. The revised energy charge part of EPTPL's tariff relating to fuel indicated at Annex-1 to Annex-3 shall be immediately applicable.
- 7. The Authority vide its decision dated June 15, 2022 approved the tariff at COD stage. EPTPL filed a petition before the Honorable High Court of Sindh (hereinafter refer as "SHC") against the decision of the Authority dated June 15, 2022. The SHC through its Order dated July 20, 2022 suspended the decision dated June 15, 2022. EPTPL also challenged the COD decision in the NEPRA Appellate Tribunal (NAT) and NAT on October 6, 2022 passed Order that recovery of costs imposed by impugned order (COD order) is suspended and indexation be allowed to the appellant according to indexation adjustment already allowed by NEPRA on provisional basis, subject to the final out-come of this appeal. Accordingly, the revised fuel cost components have been worked out in pursuance of decision dated March 13, 2015.
- 8. This decision along with Annex-1 to Annex-3 are to be notified in the official Gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
- 9. CPPA(G) to ensure that all payments are consistent with tariff determination(s).
