ISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR SINDH NOORIABAD POWER COMPANY (PRIVATE) LIMITED.

- Pursuant to the Authority's decision dated August 4, 2017 notified vide S.R.O No. 26(I)/2018 on January 5, 2018 in the matter of Motion for Leave for Review and decision of the Authority dated September 21, 2021 notified vide S.R.O. No. 727(I)/2022 on May 31, 2022 in the matter of fuel cost component & capacity charge components adjustments based on order of the Authority regarding heat rate and net capacity approval of Sindh Nooriabad Power Company (Pvt.) Ltd. (hereinafter SNPCL) dated June 4, 2021, the fuel portion of energy charge part of tariff of SNPCL has been adjusted for variation in gas price(s).
- The Honorable Supreme Court of Pakistan (SCP) in its Judgment dated August 13, 2020 has restrained the Federal Government from charging Gas Infrastructure Development Cess (GIDC) until the amount collected and accrued has not been expended on the projects as listed in the Section 4 of the GIDC Act, 2015.
- Ministry of Energy (Petroleum Division) vide its letter No. DGO (AC)-8 (49)/20 dated 19th August 2020 directed the concerned entities that the gas bills for the month of August 2020 and onward will not include or reflect GIDC rates and will remain unbilled till further orders...
- Oil and Gas Regulatory Authority (OGRA) vide its notification dated June 29, 2025 has notified gas price of Rs. 1,225/MMBTU with effect from July 1, 2025. Based on OGRA's notified gas price and in accordance with the adjustment mechanism stipulated in the decisions of the Authority, the fuel cost component has been revised. The revised energy charge part of SNPCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:
