### <u>DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT</u> OF THE TARIFF OF LARAIB ENERGY LIMITED (LEL)

1. Pursuant to the decisions of the Authority dated 14th April 2016 in the matter of tariff adjustment at Commercial Operation Date (COD), notified vide SRO 585(I)/2016 dated June 28th 2016, Motion for Recalculation dated 26th May 2016 and Motion for Review filed by LEL against the decision of the Authority at COD dated June 30th 2016, based on information provided by LEL, the insurance component is subject to adjustment as per actual. Through CPPA-G, LEL requested approval of an insurance component of Rs. 0.4895/kWh for the 12th agreement year. LEL in support of its request provided premium invoices, SBP approval and bank account statements. The details are as under:

- 2. It was noted that the claimed amount also included an amount of Rs. 9,824,056 pertaining to the valuation fee of Rushton International, which was not adequately supported. Accordingly, CPPA-G was asked vide letter dated December 20, 2024 to provide the same.CPPA-G in its reply did not address the queries raised in the said letter, therefore, the subject amount has been set aside.
- 3. The Authority in its collective and joint wisdom after examining from all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information/documents provided by LEL and in accordance with Schedule 8 of the PPA, the insurance component of the tariff for the insurance coverage period of March 23, 2024 to March 22, 2025 has been revised and is indicated hereunder shall be immediately applicable."
