# DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF FOR ACT WIND (PRIVATE) LIMITED

Pursuant to the Decision of the Authority dated April 09, 2021 in the matter of application filed by Central Power Purchasing Agency Guarantee Ltd. (CPPAGL) notified through S.R.O 719(I)/2021 dated June 04, 2021, Act Wind (Pvt.) Limited (AWPL) (formerly Tapal Wind Energy (Pvt.) Limited) requested for the revised insurance cost and corresponding component of tariff for the period from October 08, 2024 to October 07, 2025.
