DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF OF SACHAL ENERGY DEVELOPMENT (PVT.) LIMITED

Pursuant to the decision of the Authority dated June 01, 2018 in the matter of tariff adjustment of Sachal Energy Development (Pvt.) Limited (SEDPL) at Commercial Operations Date (COD), SEDPL requested for the revised insurance cost and corresponding component of tariff for the period from April 11, 2025 to April 10, 2026.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the SEDPL, adjustment in insurance component for the period April 11, 2025 to April 10, 2026 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder shall be immediately applicable."

Based on the data declared by SEDPL and revised insurance is 0.40% of allowed EPC cost.

- 3. The claims of insurance with respect to motor insurance, health and life insurance have not been considered as the same are not covered in the scope of insurance as given in the EPA.
- 4. The revised tariff component is to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
- 5. CPPA-G to ensure that all the payments are consistent with tariff determination.
