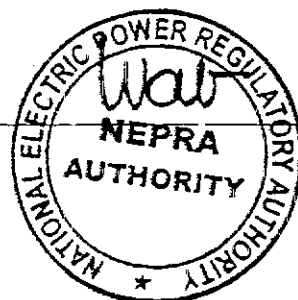

**DECISION OF THE AUTHORITY IN THE MATTER OF REVISION IN THE
PREVIOUS APPROVED FUEL COST COMPONENTS FOR THE MONTHS
OF OCTOBER 2024 TO MARCH 2025 FOR THALNOVA POWER THAR
(PVT.) LIMITED**

1. Pursuant to the decision of the Authority dated October 18, 2016 notified vide S.R.O. No. 728(I)/2017 on June 14, 2017, in the matter of approval of Thar Coal Upfront Tariff for 330 MW Coal Power Plant of ThalNova Power Thar (Pvt.) Limited (TNL), the variable and fixed fuel cost components are subject to adjustment on the basis of coal price determined by Thar Coal Energy Board (TCEB) and notified in the Official Gazette.
2. The Authority through its various decisions, has determined fixed and variable Fuel Cost Components (FCCs) for the months of October 2024 to March 2025 on the basis of applicable reference mine COD of Phase-II of Block-II tariff, determined by TCEB and invoiced by its fuel supplier i.e. Sindh Engro Coal Mining Company (SECMC) to TNL. These FCCs' decisions are required to be revised on the basis of quarterly indexed/adjusted mine tariffs determined by TCEB for October-December 2024 and January-March 2025 quarters, respectively. TCEB issued its decisions on quarterly indexed/adjusted mine tariff through Orders dated February 25, 2025 and May 26, 2025, respectively and notified in the Government of Sindh's Official Gazette on March 17, 2025 and July 14, 2025, respectively.
3. TNL vide its letter dated July 31, 2025 submitted request for the revision of FCCs for period from October 2024 to March 2025, based on TCEB's quarterly indexations decisions for October-December 2024 to January-March 2025 quarters of Phase-II of Thar Coalfield Block-II. This request was made after TNL received requisite invoices from its fuel supplier on May 16, 2025 and July 16, 2025, respectively. Additionally, TNL sought approval of Rs. 220,001,000/- (for October-December 2024) and Rs. 118,141,423 (for January-March 2025) as pass-through for duties and taxes incurred and invoiced by SECMC, based on TCEB's note, "Duties and taxes to be recovered based on actuals for respective quarter" as outlined in the quarterly indexation decisions.
4. The Authority has considered the submissions of TNL. It has been noted that the requests for pass-through of duties and taxes are without any verification and approval of TCEB and cannot be considered. Therefore, TNL is directed to ask its fuel supplier to get it verified and approved from TCEB and submit revised request along with TCEB decision(s) in the matter and documentary evidence for consideration of the Authority. Based on the above decision of the Authority, the requested duties and taxes amount of Rs. 338,142,423/- has been set aside.

5. Based on TNL's submissions, documentary evidences and above discussions, the Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of the Authority in the matter:-

"The previously approved variable and fixed fuel cost components of energy charge part of TNL's tariff for the months of October 2024 to March 2025 are being revised on the basis of TCEB's quarterly indexation/adjustment decisions for October-December 2024 to January-March 2025 quarters, as notified in Official Gazette, excluding taxes and duties of Rs. 338,142,423/-. TNL is directed to ask its fuel supplier i.e. SECMC to get the exact amount of taxes and duties verified and approved from TCEB. On the basis of approval and verification by TCEB, SECMC shall invoice the same to TNL who will submit the same along with documentary evidence for consideration of the Authority."

6. The revised energy charge part of TEL's tariff relating to fuel indicated at Annex-1 to Annex-6 shall be immediately applicable.
7. This decision along with Annex-1 to Annex-6 are to be notified in the official Gazette in accordance with Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997 (XL of 1997).
8. CPPA(G) to ensure that all payments are consistent with tariff determination(s).

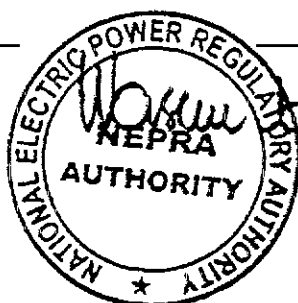

Adjustment on Account of Thar Coal Price Variation for the month of October 2024

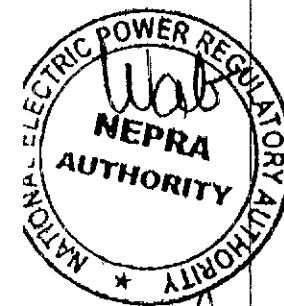

Adjustment on Account of Thar Coal Price Variation for the month of November 2024

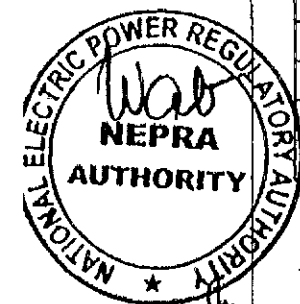

Adjustment on Account of Thar Coal Price Variation for the month of December 2024

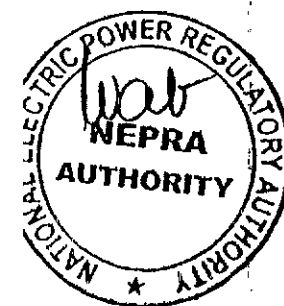

Adjustment on Account of Thar Coal Price Variation for the month of January 2025

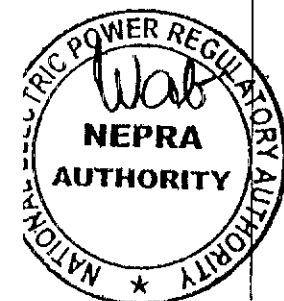

Adjustment on Account of Thar Coal Price Variation for the month of February 2025

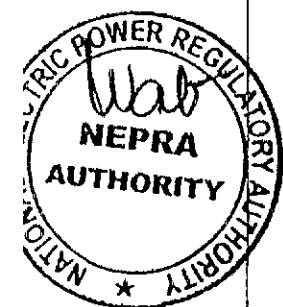

Adjustment on Account of Thar Coal Price Variation for the month of March 2025

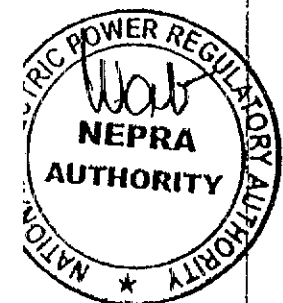
