DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF TARIFF OF THREE GORGES THIRD WIND FARM PAKISTAN (PVT) LIMITED

Pursuant to the decision of the Authority dated January 08, 2019 in the matter of tariff adjustment of Three Gorges Third Wind Farm Pakistan (Pvt) Limited (TGTWFPL) at Commercial Operation Date (COD) notified vide S.R.O.
