- Pursuant to the Decision of the Authority dated May 24, 2010 in the matter of Motion for Leave for Review 1. filed by Attock Gen Limited (AGL) against the decision of the Authority dated July 30, 2009 in the matter of adjustment at Commercial Operation Date (COD), decision of the Authority April 2, 2021 in the matter of application filed by CPPA-G for adjustment of ROE & ROEDC components of tariff pursuant to the agreement with AGL and May 27, 2025 in the matter of joint application filed by CPPA-G and AGL for reduction in tariff components, withholding tax on dividend is a pass through item as per COD decision and the power purchaser shall make payment on account of withholding tax at the time of actual payment of dividend.
