DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT FOR JUL-SEP 2023 TO OCT-DEC 2024 QUARTERS IN FOREIGN INTEREST COMPONENTS OF TARIFF OF APPOLO SOLAR DEVELOPMENT PAKISTAN LIMITED

Pursuant to the Decision of the Authority dated November 16, 2017 in the matter of tariff adjustment of Appolo Solar Development Pakistan Limited (ASDPL) at COD notified vide SRO 119(I)/2018 dated January 25, 2018 and Authority's decisions dated 5th & 13th December, 2024 regarding transition from LIBOR to SOFR effective from July 01, 2023 which was notified vide SRO 73(I)/2025 dated January 28, 2025.

- The Authority through its various decisions appröved Foreign Interest and Sinosure Components of 2. tariff w.e.f. July-September 2023 to October-December 2024 quarters based on available LIBOR till decision on transition from LIBOR to SOFR and its notification in the Official Gazette.
- Subsequent to the notification of the decisions, ASDPL vide letter dated April 17, 2025 requested for revision of Foreign Interest and Sinosure components based on SOFR values from July-September 2023 to October-December 2024 quarters.
- The Authority in its collective and joint wisdom decided with consensus as under; which will be 4. hereafter called as decision of the Authority in the matter.

'Foreign Interest and Sinosure components have been revised on account of SOFR variation in accordance with the requisite indexation/adjustment mechanism stigulated in the decision of the Authority dated 5th & 13th December 2024. The revised tariff indicated at Annex-I shall be immediately applicable."

- The instant decision shall supersede the relevant decisions of the Authority to the extent of Debt Servicing (Foreign) and Sinosure components dated August 17, 2023, November 15,2023, February 12, 2024, May 07, 2024, August 06, 2024 and November 07, 2024 related to July-September 2023 to October-December 2024 quarters.
- The adjusted/indexed tariff attached as Annex-I is to be notified in the official Gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- CPPA-G to ensure that all the payments are consistent with tariff determination. 7.
