DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR CHINIOT POWER LIMITED FOR THE QUARTER OCT-DEC 2025

Reference is made to the Authority decision in the matter of application of Chiniot Power Limited ("CPL") opting for Upfront Tariff on January 22, 2016, decision regarding one-time Adjustment in the Upfront Tariff of CPL issued on February 24, 2016, corrigendum dated October 31, 2016, and decision dated June 17, 2025 in the matter of joint application filed by CPPAG and CPL.

- 5. CPPAG to ensure that all the payments are consistent with tariff determination.
