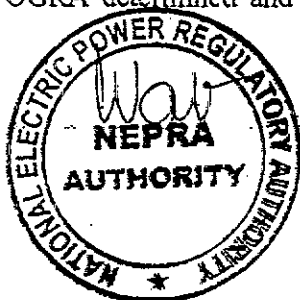

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE
ADJUSTMENTS ON RLNG FOR THE MONTHS OF JULY 2023 TO JUNE 2025
FOR K-ELECTRIC LIMITED.**

1. Pursuant to the Authority's decision dated October 22, 2024, notified vide S.R.O. 1988 on December 4, 2024, in the matter of tariff petition filed by K-Electric Limited (hereinafter refer as "KE") for its power generation plants, the Fuel Cost Components (FCCs) of tariff are required to be adjusted on account of variation in fuel prices.
2. KE on August 11, 2025 requested for the revisions of FCCs on combined and open cycle operations for July 2023 to June 2025 for its power generation plants on RLNG and Natural Gas. As per the information and documentary evidences provided by KE, Pakistan LNG Limited (PLL) supplied RLNG to Bin Qasim Power Station-I (BQPS-I), BQPS-II and BQPS-III. Similarly, Sui Southern Gas Company (SSGC) supplied RLNG to BQPS-I, BQPS-III, Korangi Combined Cycle Power Plant (KCCP), Korangi Gas Engine Power Station (KGTPS) and Site Gas Turbine Power Station (SGTPS). SSGC also supplied Natural Gas to BQPS-I, BQPS-II KCCP, KGTPS and SGTPS. KE also requested FCCs on High-Speed Diesel (HSD) and Residual Fuel Oil (RFO) fuels.
3. KE on October 17, 2025 informed that PLL invoiced to KE for the months of July 2023 to October 2023 based on provisional RLNG prices determined by OGRA for SNGPL/SSGS and O&M cost is charged as per the Economic Coordination Committee (ECC) decision, as PLL maintains the Custody Transfer Station (CTS) which cannot be recovered elsewhere. KE apprised that from December 2023 onwards, OGRA's provisional RLNG price determinations for PLL include O&M cost. KE requested that RLNG prices be considered either based on PLL invoices or OGRA's determinations. The Authority has accepted KE's request to adjust FCCs on the basis of PLL invoices and/or OGRA determined prices. Since OGRA's notified RLNG prices are provisional, these FCCs shall be subject to adjustment as per final/actual RLNG prices determined by OGRA.
4. Furthermore, KE in support of its request for the revisions of FCCs, referred clause 7.1(b)(ii) of GSA, which states that if OGRA does not determine/notify the provisional RLNG price for respective month, provisional RLNG price previously determined/notified by OGRA will be applied by PLL for billing. Accordingly for the months of September 2023 and February-June 2025, KE requested to apply previous prices as OGRA did not determine revised provisional prices for the subject months.
5. In accordance with the Authority's prescribed mechanism, fuel cost components for RLNG have been revised based on OGRA's determinations, PLL invoices and documentary evidences & information provided by KE. The revision has been made on provisional basis and in case OGRA determined and notified the actual/final RLNG price(s), the fuel cost





components shall be revised. The revised RLNG prices along with revised FCCs are attached in Annex-I to V and shall be immediately applicable on the unit delivered basis. The decision regarding revisions of FCCs on the basis High Speed Diesel (HSD) and Residual Fuel Oil (RFO) fuels shall be issued separately.

6. The above decision of the Authority along with revised fuel cost components attached as Annex-I to V are to be notified in the Official Gazette in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

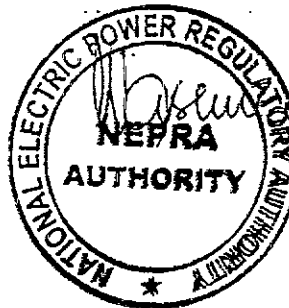
