**S.R.O. 2429 (I)/2025.-** In pursuance of Proviso-ii of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority dated November 25, 2025 along with revised tariff components attached as **Annex-I, Annex-II & Annex-III** in the matter of quarterly indexation/adjustment of tariff for **January - March 2025 to October - December 2025** quarters for National Power Parks Management Company (Private) Limited for its power project at Haveli Bahadar Shah on account of US CPI, N-CPI and Exchange Rate variation in Case No. NEPRA/TRF-358/NPPMCL-2016.

2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.



**REVISED DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATIONS/ADJUSTMENTS OF TARIFF FOR JANUARY-MARCH 2025 TO OCTOBER-DECEMBER 2025 QUARTERS FOR NATIONAL POWER PARKS MANAGEMENT COMPANY (PRIVATE) LIMITED FOR ITS POWER PROJECT AT HAVELI BAHADAR SHAH.**


1. Pursuant to the Authority's decision dated February 19, 2020 in the matter of tariff adjustments at Commercial Operation Date (COD) of National Power Parks Management Company (Private) Limited for its Power Project at Haveli Bahadar Shah (hereinafter "NPPMCL-HBS"), decision of the Authority dated May 20, 2020 notified vide S.R.O. No. 484(I)/2021 in the matter of Review Motion against COD decision, the decision of the Authority dated March 10, 2021 notified vide S.R.O. No. 1041(I)/2023 on August 09, 2023 in the matter of change of base year 2007-2008 to base year 2015-16 for Consumer Price Index (CPI) for indexation of fixed and variable O&M (Local) components, decision(s) of the Authority dated February 03, 2025 and March 27, 2025 regarding Modification Petition for the COD tariff and decision of the Authority dated July 30, 2025 in the matter of joint application filed by CPPA-G and NPPMCL-HBS for reduction in tariff components, the relevant tariff components are required to be adjusted on account of US CPI, N-CPI, Exchange Rate and KIBOR variation.
2. In accordance with the Authority's decision dated July 30, 2025, NPPMCL-HBS submitted request for quarterly indexations/adjustments of relevant tariff components for January-March to July-September 2025 quarters which was decided by the Authority through its decision dated August 29, 2025. It has been noted that there are inadvertently typo errors in the decision, therefore, correction has been required in the decision dated August 29, 2025. NPPMCL-HBS also submitted request for quarterly indexation/adjustment of relevant tariff components for October-December 2025 quarter.
3. Accordingly, the tariff of NPPMCL-HBS in respect of January-March to October-December 2025 quarters have been revised on account of US CPI, N-CPI and Exchange Rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the above decision(s) of the Authority.
4. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which shall be hereafter called as decision of Authority in the matter:-  
  
"Indexations/adjustments for January-March to October-December 2025 quarters have been made in the tariff components in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised components attached as **Annex-I, Annex-II & Annex-III** shall be immediately applicable."
5. The above decision of the Authority shall supersede the previous decision of the Authority dated August 29, 2025.
6. The above decision of the Authority along with revised tariff components attached as **Annex-I, Annex-II & Annex-III** are to be notified in the Official Gazette, in terms of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
7. CPPA (G) to ensure that all payments are consistent with the tariff determination(s).






