

- S.R.O. 2441 (I)/2025.- In pursuance of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the Decision of the Authority dated November 11, 2025 in the matter of Reimbursement of Pass-Through Withholding Tax on Dividends for Star Hydro Power Limited in Case No. NEPRA/TRF-172/SHPL-2011.
- 2. While effecting the Decision, the concerned entities including Central Power Purchasing Agency Guarantee Limited shall keep in view and strictly comply with the orders of the courts notwithstanding this Decision.

DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF PASS-THROUGH WITHHOLDING TAX ON DIVIDENDS FOR STAR HYDRO POWER LIMITED (SHPL)

Pursuant to the Decisions of the Authority dated July 29, 2020 in the matter of Tariff Adjustments at Commercial Operation Date (COD), actual withholding tax on dividend paid by the power producer will be reimbursed subject to a maximum of 7.5% of 17% return on equity. The Authority hereby allows Star Hydro Power (SHPL) to claim Rs.577,277,027/- as a pass-through on account of withholding tax on dividends from Central Power Purchasing Agency Guarantee Limited.

- 2. The schedule attached as Annex-I is to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 3. CPPA (G) to ensure that all payments are consistent with tariff determination(s).
