**DECISION OF THE AUTHORITY IN THE MATTER OF ANNUAL
INDEXATION/ADJUSTMENT OF TARIFF FOR JAGRAN-I HYDROPOWER
PROJECT AJ&K**

Pursuant to the Decision of the Authority dated 14th September 2018 in the matter of tariff proposal submitted by Central Power Purchasing Agency Guarantee Limited (CPPA-G) for Import of power from 30.4 MW Jagran-I Hydropower Project located in AJ&K notified vide S.R.O No. 937(I)/2019 dated August 16, 2019, the variable component of the of Jagran-I Hydropower Station on account of annual average local CPI for the period from September 2025 to August 2026 has been revised in accordance with requisite indexation/adjustment mechanism stipulated in the decision of the Authority as indicated in Annex-I.

2. CPPA-G forwarded the request of Azad Jammu & Kashmir Power Development Organization for Jagran-I Hydropower Station for indexation/adjustment of tariff components for the period September 2025 to August 2026.
3. Accordingly, the Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as the decision of the Authority in the matter:

"The variable component of tariff has been indexed for the period September 2025 – August 2026 on account of N-CPI Local. The revised tariff indicated in the attached Annex-I shall be immediately applicable."

4. The above referred revised tariff components attached as Annex-I is to be notified in the official gazette, in terms of Section 31(7) of the Regulation of Generation, Transmission, and Distribution of Electric Power Act, 1997.
5. CPPA-G to ensure that all payments are consistent with the tariff determination(s).

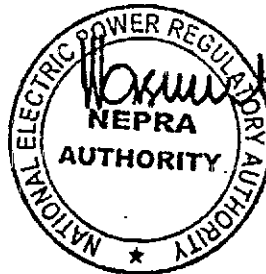

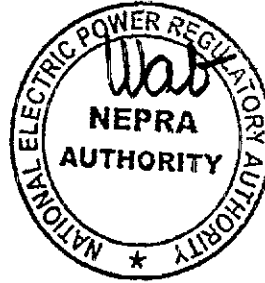
