**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE
COMPONENT OF TARIFF FOR ACT WIND (PRIVATE) LIMITED**

Pursuant to the Decision of the Authority dated April 09, 2021 in the matter of application filed by Central Power Purchasing Agency Guarantee Ltd. (CPPAGL) notified through S.R.O 719(I)/2021 dated June 04, 2021, Act Wind (Pvt.) Limited (AWPL) (formerly Tapal Wind Energy (Pvt.) Limited) requested for the insurance component of Rs. 1.2902/kWh based on actual insurance premium of Rs. 105,111,090 for the period from October 08, 2025 to October 07, 2026.

2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

"Based on the information provided by the AWPL, adjustment in insurance component for the period October 08, 2025 to October 07, 2026 has been made in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised component is indicated hereunder."

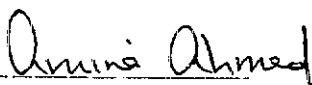

* Revised Insurance premium has been worked out on the basis of actual premium which is 0.57 % of the EPC cost and is less than the benchmark cost of 0.7 % of the EPC cost.

3. The revised insurance component of tariff is to be notified in the official Gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997(XL of 1997).

4. CPPA-G to ensure that all the payments are consistent with tariff determination.

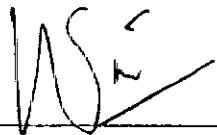

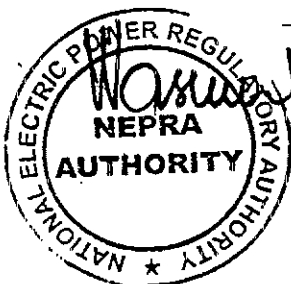
