**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT
OF TARIFF FOR CHINIOT POWER LIMITED FOR THE QUARTER JUL-SEP 2026**

Reference is made to the Authority decision in the matter of application of Chiniot Power Limited ("CPL") opting for Upfront Tariff on January 22, 2016, decision regarding one-time Adjustment in the Upfront Tariff of CPL issued on February 24, 2016, corrigendum dated October 31, 2016, and decision dated June 17, 2025 in the matter of joint application filed by CPPAG and CPL.

2. In accordance with the requisite indexation/adjustment mechanisms stipulated in the aforementioned decision(s) of the Authority, CPL vide letter dated Jul 06, 2026 requested the Authority to index the tariff for Jul-Sep 2026.

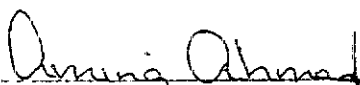
3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

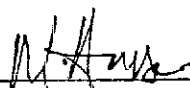

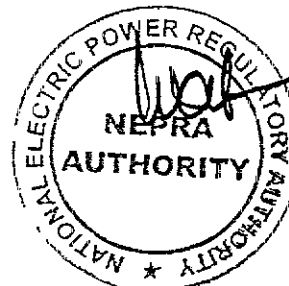
