**DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF WITHHOLDING TAX
ON DIVIDEND FOR THREE GORGES FIRST WIND FARM PAKISTAN (PRIVATE) LIMITED**

Pursuant to the decision of the Authority dated January 22, 2016 in the matter of tariff adjustment of Three Gorges First Wind Farm Pakistan (Pvt.) Limited (TGF) at Commercial Operation Date (COD) notified vide S.R.O No 361(I)/2016 dated April 20, 2016 and Motion for Leave for Review decision dated October 28, 2016 against the Decision of the Authority at COD. TGF has requested the Authority for the reimbursement of WHT on dividend.

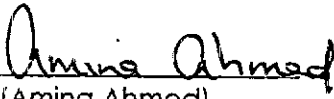
2. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:

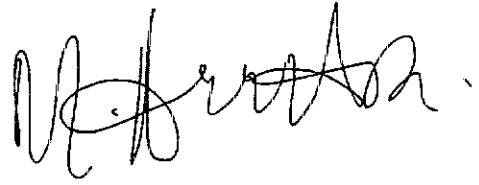
"TGF requested for the reimbursement of Rs. 153,280,554 on account of 7.5% withholding tax ("WHT") on Interim cash dividend pertaining to the period ended December 31, 2025. The Authority has considered the request of TGF and decided to approve the requested amount of Rs. 153,280,554 to be reimbursed by the power purchaser to TGF."

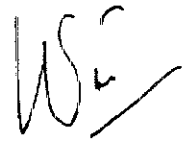

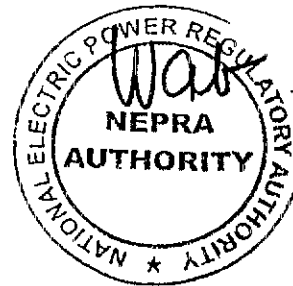
