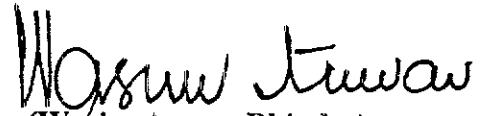

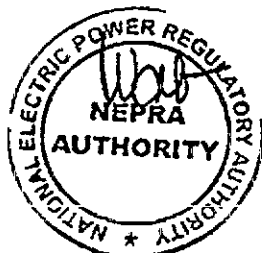

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE
ADJUSTMENT FOR THE MONTH JUNE 2026 FOR HUANENG SHANDONG
RUYI (PAKISTAN) ENERGY PRIVATE LIMITED**

1. Pursuant to the Authority's decision dated March 31, 2015 in the matter of Approval of Upfront Coal Tariff for 2x660 MW coal power plant of Huaneng Shandong Ruyi (Pakistan) Energy Private Limited (HSRPEL), decision dated September 23, 2016 regarding Suo Moto Review Proceedings in the Fuel Price Adjustment Mechanism, decision dated February 15, 2018 regarding inland freight charges, decision dated January 17, 2019 in the matter of tariff adjustment at Commercial Operation Date (COD) of HSRPEL and decisions dated August 22, 2019, May 6, 2021 and May 26, 2025 in the matter of motion for leave for review regarding fuel price adjustments, the fuel portion of the energy charge part of HSRPEL's tariff has been adjusted for variation in coal price(s). HSRPEL requested weighted average coal price of Rs. 52,954/Ton for the coal consumed during the month of June 2026. HSRPEL requested fuel cost component of Rs. 20.4309/kWh for June 2026.
2. HSR claimed LC charges on the basis of 0.1% of the CFR value of each shipment. However, the invoices showed that the coal supplier had charged LC charges of US\$0.10/ton. Therefore, LC charges have been considered at the actual invoiced rate of US\$0.10/ton for each shipment.
3. HSR claimed LC settlement exchange rate for each shipment. However, the invoices showed that the coal supplier had charged average exchange rate for the month of Bill of Lading which was lower than the requested rate. Accordingly, actual invoice exchange rate for each shipment has been used.
4. The Marine freight has been worked out on the basis of 42,300 tons and 50,000 tons or actual ship quantity whichever is higher for ships unloaded at PQA Marginal Wharf 3 & 4 and PIBTL respectively and on the basis of provided documentary evidences, PDA charges have also been worked out on the basis of respective quantities.
5. During the month, HSR also consumed coal procured from the spot market, the price of which exceeded the ceiling price computed as per the Guidelines for Procurement of Spot Coal dated January 02, 2023. Accordingly, the coal price has been capped at the ceiling price which is significantly less than the requested price as mentioned in Annex-II.
6. The Authority in its collective and joint wisdom considering all aspect decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:
