In continuation of above references & pursuant to Para 48(7) & 49(1) of NEPRA Guidelines for determination of Consumer End Tariff (Methodology & Process) 2015 notified vide SRO# 34(1)/2015 dated 16/01/2015 and based on the formula for calculation of Quarterly/ Bi-annual adjustment given at para 16.5 of Re-Determination of MEPCO's Tariff for FY 2015-16, MEPCO hereby submits in combine the quarterly adjustments for all the four quarters of FY 2017-18 on account of Power Purchase Price.

The total amount of quarterly adjustment for the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> quarter of FY 2017-18 comes to Rs. 3,187(M), Rs.6,329(M), Rs.7,470(M) & Rs.12,663(M) respectively as calculated at Annex-A to D of this letter.
